University of Washington:

- Busy with school field trips. Gardeners planting in Rhododendron Glen. The Arboretum is preparing for Mother's Day.
- Restoration ecology students are planting natives in Pinetum and on Foster Island.
- UWBG signed an MOU with Black Star Farmers to use the garden beds by the greenhouse to grow food.

#### **Arboretum Foundation:**

- John Grotti installation is going to be done soon. Planning a work party and celebration near the end of August.
- Community Survey is set to launch on Mother's Day.
- The Foundation has received 2 \$1million gifts towards the Arboretum. Donors have created a pool of funds that will provide ongoing funds for the Arboretum, including paying for the new horticulture position.
- 180 volunteers for Earth Day.
